#2 1000 Minute Plan*

1000 min/mo for unlimited phone lines bundled.
Minutes over 1000 @ 6¢/minute.
Call detail records optional @ \$5⁰⁰/mo. per calling plan

#3 500 Minute Plan*

500 min/mo for unlimited phone lines bundled.
Minutes over 500 @ 8¢/minute.
Call detail records optional @ \$5⁰⁰/mo. per calling plan

#5 10¢/Minute Plan*

Unlimited calling @ 10¢/min for one phone line.
Call detail records included & itemized monthly.
Plan is effective anytime.

\$1⁰⁰/mo plus 10¢/minute

#4 6¢/Minute Plan*

Unlimited calling @ 6¢/min for one phone line.
Call detail records included & itemized monthly.

*TCT Long Distance Calling Plans provide calling to all 50 United States plus Canada. Plans #1, #2, #3 & #4 are effective the day immediately following the previous month's toll cutoff. Fax calls and calls made to modems may not complete. Plans are available on any TCT residential or business telephone account. Residential & business phone lines may not be combined on one plan. Residential plans must originate from one household. Customers not choosing the monthly call detail records option on Calling Plans #1, #2 or #3 may purchase them for \$15⁰⁰ per line for each billing month, as needed.

Please add a TCT Calling Plan listed above to the following telephone numbers. If plan #1, #2 or #3 is selected, and I choose to have call detail records printed on my monthly bill, I agree to pay \$5⁰⁰/month per calling plan for the records. I understand that TCT will pay any PIC change charges associated with this request. I also understand the selected plans will go into effect only during the toll cutoff period indicated above.
